INTERNET USE POLICY

General Definitions

- This usage policy fulfills the requirements of the “ULAKNET Usage Policy” agreement, which was drawn up to determine the procedures and principles regarding the use of the National Academic Network (ULAKNET) operated by the National Academic Network and Information Center (ULAKBİM). It also sets the Internet and information systems services provided to the users in all units of Selçuk University and the rules regarding the use of these services.
- Users are not only the academic and administrative staff of our university, but also our students of all levels.
- All informatics and Internet services used in our university are provided in accordance with ULAKBİM Usage policy and regulations. Users must comply with these rules.

Usage Policy

- Users using the Internet service in our university units must undertake to abide by the rules stated below.
- Our university's Internet network service is used to access the most up-to-date information on education and technological innovations, to conduct academic research, and to disseminate this information.
- Information and transport accesses on the network are provided in accordance with the relevant legal regulations.
- The Internet service provided by ULAKNET to our university cannot be given to commercial and non-commercial third individuals or organizations for any fee or interest.

Our university's Internet service cannot be used for the following purposes.

- Sending unsolicited messages (SPAM messages), such as commercial advertisements and news announcements.
- Using any user's mail server to send messages without their explicit permission.
- To create traffic regulations that will negatively affect or disrupt the service quality of our university's Internet network or create chaos on the network.
- Producing and distributing obscene and offensive images that are not suitable for their intended use (except for academic and research purposes).
- Producing and distributing material that is untrue, distressing, disturbing, or causing fear.

- Producing and distributing slanderous and defamatory materials.
- Distributing material (including but not limited to articles, articles, books, films, musical works) that violates the intellectual rights of others.
- Using national or international services through ULAKNET in an unauthorized and deliberate manner.
- Destroying other people's data and distributing it without their knowledge.
- To save and use our university's online databases, online archives and the like on their personal computers in violation of the rules.
- Insisting on using applications that have been canceled by the IT Department on the grounds that they prevent the Internet network from working and generate unnecessary traffic.

Rights, Authorities and Responsibilities

- Those who read this Usage Policy are aware that our university can control the use of the Internet network in accordance with the determined rules, without prejudice to the personal rights of the user, and they openly accept this.

Implementation and Execution

Implementation and Execution

- The rules and practices in this document are valid and applied to all Internet users in our university. All parties are obliged to comply with these rules.
- In case of use that does not comply with these rules and practices, the IT Department uses its authority to take the necessary measures and warns the users verbally and in writing.
- Upon improper use, the user's Internet access may be restricted or blocked.
- If practices that are inappropriate and harmful to the system still continue, judicial and administrative inquiry mechanisms are applied.
