## 1. GENERAL INFORMATION, BASIC PRINCIPLES AND RULES

-Candidates from abroad or foreign nationals who want to study at Selçuk University in associate and undergraduate undergraduate and evening programs can apply within the Selçuk University International Student Selection and Placement Process.

-This guideline includes the application process and provisions for the student who desire to apply for the International Student Selection process in order to study at Selçuk University during the education year of 2023- 2024

-Related to the communication between Selçuk University Coordinatorship for Foreign Students Selection Exam and the candidates (email, mail, fax etc.), only Turkish language is employed.

-Throughout the communication, SUYOS Coordinatorship cannot be held liable for the imperfect and wrong information and delays and failures in the communication instruments (mail, internet etc.)

-The International Student Selection process is only for students who desire to study at the associate degree and bachelor degree. The transfer procedures of the foreign students who have been studying at a university and desire to study at a graduate program of Selçuk University are out of the scope of the Foreign

-Selçuk University Coordinatorship for Foreign Students Selection Exam doesn't deal with the procedures related to the students such as accommodation, scholarship, living expenses and residence permit in Turkey.

-The processes and provisions of this guideline may be altered via the decisions of the Higher Education. In that case, the procedures to follow are determined by Selçuk University Coordinatorship for Foreign Students Selection Exam. The occasions not mentioned in this guideline are handled according to the decisions of Selçuk University Coordinatorship for Foreign Students Selection Exam.

**The SUYÖS-2024 guideline may be accessed only through internet.**

## 2.TERMS OF APPLICATION

On condition that the candidates are at the last grade of high school or are graduated from those schools, the applications from the students described below will be accepted;

1.Foreign nationals, (provided that those studying in secondary education (high school) institutions in Turkey have registered before the 2022-2023 academic year [Except for Embassy schools, International private education institutions taking place in the MOBIS system and foreigners brought to our country within

the framework of the project carried out by the Ministry of National Education])

2) Those who became Turkish citizens at birth and who were allowed to be out of Turkish citizenship given by the Ministry of Internal affairs and their non-adult children registered in their document to cease to be a citizen of Turkey who can provide the certificate related to the Use of the Given Rights according to the Turkish Citizenship Law (It will be better to analyze Turkish Citizenship Law since the Turkish Law 5901, article No7 clause (1) states that “the child who was born within Turkey or abroad from a Turkish mother or father within a marriage community is a Turkish citizen).

3) The individuals who were foreign from birth and turned into a citizen of Turkish Republic afterwards / and those with dual nationality in the same condition (On the condition that those studying in secondary education (high school) institutions in Turkey have registered before the 2022- 2023 academic year)

4) Those who are Turkish citizens and completed their entire secondary education (high school) in a foreign country other than TRNC (including those who completed their entire

secondary education [high school] in Turkish schools opened by the Ministry of Education in a foreign country other than TRNC

5) Among the candidates who are the citizens of TRNC, reside in the TRNC and completed their secondary education (high school) in TRNC, those having the GCE AL exam results and the students registered to the colleges and high schools in the other countries between the years of 2005 and 2010 and possess the GCE AL exam results or who will have it in the future.

Among the candidates, the applications of the candidates who are defined below aren't accepted;

1.Those who has T.R. nationality and completed their secondary school (high school) education either in Turkey or in the foreign countries,

2. Among the candidates from TRNC (except those who completed their secondary school education in the TRNC and have the GCE AL results and those who registered to the colleges and high schools in the other countries between the years of 2005 and 2010 and have the GCE AL results or will have soon),

3) The individuals with double nationality and turned into Turkish citizens as a result of the birth which was defined in this guide in Article 2 of the section describing

the candidates whose applications will be accepted (except those who meet the requirements in the clause a of Article 4 of the section describing the candidates whose applications will be accepted in this guide),

4) Among the candidates with dual nationality whose one nationality is in TRNC (except those who completed all the secondary school education (high school) in the TRNC and those who registered to the colleges and high schools in the other countries between the years of 2005 and 2010 and have the GCE AL results or will have soon),

5) The citizens of Turkish Republic who study at the schools within the structure of embassies in Turkey and in the foreign high schools in Turkey and the individuals with dual nationality who became Turkish citizen due to the birth which was defined in this guide in Article 2 of the section describing the candidates whose applications will be accepted,

6) TRNC citizens who will enroll in secondary education institutions in Turkey from the 2022- 2023 academic year and those who have renounced their Turkish citizenship/Blue Card holders and foreign nationals [Except for Embassy schools, International private education institutions taking place in the MOBIS system and

foreigners brought to our country within the framework of the project carried out by the Ministry of National Education]

### 3. APPLICATION DATES

If deemed necessary, an additional application and selection process will be conducted for student admissions in the 2024/2025 Academic year.

### 4. APPLICATION PROCEDURES

The applications to the SUYOS-2024 from inside and outside of the country will be conducted through web site of Selçuk University Coordinatorship for Foreign Students Selection Exam. (<https://suyos.selcuk.edu.tr/>)

All candidates who want to apply should fill in the “SUYÖS-2024 Application Form” online on the web page of Selçuk University Coordinatorship for Foreign Students Selection Exam within the application period. Except the online application, no other ways of application will be accepted.

#### Points to Consider in Filling the Application Form:

- The information provided by you should be the same as the information in your passport. Otherwise, you aren't accepted to the exam.
- The photo that you will upload to the application form should be taken within the last six months. Your face should be clearly seen in the photo and should be taken from front.
- In case there are errors and imperfect information in the application form, your application will be regarded invalid
- If you need to make alterations in the information about you after your online application is completed, you may organize

your information on your page before the application period ends.

### **Documents Required for Applications**

-Photo of the student, **where their face is clearly visible.** (Preferably biometric photo)

-Original High School Diploma and an officially approved copy translated into Turkish

-Original transcript and an officially approved transcript translated into Turkish

-Copy or photocopy of passport

-Photocopy of TR Identity Number Declaration or Identity Card of candidates with Turkish citizenship

-Military Service Status Declaration for Turkish male candidates

-Foreign Language Proficiency Certificate, if available.

-If available, Foreign Language Turkish Proficiency Certificate

-International Exam Result Document

-A copy of the population registration certificate from dual nationals who were foreign nationals by birth and later became Turkish citizens.

-The candidate must sign the letter of undertaking, the example of which is given below in this guide, and upload a copy to the system.

### **Accepted Exam Types and Points in Applications**

Exam/Diploma Types and Criteria that will be accepted for SUYÖS 2024 applications are given in Table 1. In placements, the TR-YÖS score is primarily taken into account. After the TR-YÖS score, diplomas from Maarif Schools and Turkish High Schools abroad (MEB Schools), international exam scores valid for international student admissions, are given priority. Afterwards, other diploma scores will be taken into consideration.

## 5. PREFERENCE PROCESS

**Table 1: Acceptable Exam/Diploma Types and Criteria**

- TR-YÖS, (minimum scores are valid) -Diplomas of Maarif Schools and Turkish High Schools Abroad, (MEB Schools) - (minimum scores are valid)	For Faculties of Medicine, Dentistry, Law, Pharmacy, Engineering, Midwifery, Nursing and Education
TR-YÖS, Maarif Schools and Turkish High Schools abroad diplomas, (MEB Schools) International Exams: SAT(Scholastic Aptitude Test- ACT(American College Testing); AP(Advanced Placement); IB(International Baccalaureate); GCEAL(General Certificate of Education Advanced Level) (minimum exam scores are valid, validity period is 2 years) National diploma types (ABİTUR, MATURA), (minimum scores are valid) Other high school diploma scores (minimum scores apply)	For all departments <b>except</b> Medicine, Dentistry, Law, Pharmacy, Engineering, Midwifery, Nursing and Education Faculties

Candidates will also save their preferences in the system while applying.

In the preference system, candidates have the right to make 10 choices. **Candidates should rank carefully as their order of preference will be taken into account when placing them.** You can change the preference order by clicking and dragging the added preference. The preferences made when the selection process ends will be considered as the candidate's final preferences

- Candidates should take into account the duration of study, conditions and explanations when making their choices.

Students who have been placed and registered during the initial applications will not be able to register during subsequent applications. Candidates must enter all the information requested in their preference applications completely and accurately. The preferences of candidates whose information is incomplete or incorrect will not be taken into account.

According to the relevant article of YÖK; In accordance with the Turkish Citizenship Law, candidates who were Turkish citizens by birth but lost their Turkish citizenship by obtaining permission from the Ministry of Internal Affairs to renounce their Turkish citizenship, candidates who document that they have a blue card, which is given to those who have lost Turkish citizenship upon their

request, and candidates who have completed their high school education abroad (except TRNC) and whose nationality is Turkish. For candidates with dual citizenship and Turkish citizenship, placement will be made in Dentistry, Pharmacy, Law, Teaching and Medicine programs in a way that does not exceed 10% of the quota of the said programs.

The minimum and maximum values of the scores that candidates will use in their applications are given in Table 2.

### Obtaining the Candidate Number

After you complete and approve the "SUYÖS-2024" Applications and Preferences online, the Candidate Number will be automatically sent to the e-mail address you specified in this form and will also be displayed on the registration form screen.

### Announcement of Results

Application results will be just published on Selcuk University Coordinatorship for Foreign Student Selection Exam Website.

Candidates can learn their results from the Selcuk University Coordinatorship for Foreign Student Selection Exam Website by using the Candidate Number sent to the email address specified in the candidate's application form.

The candidates can learn their application results by means of using the number written in their application form and the number sent to their e-mail adress written in their application form on the web site of.

The candidates that are accepted by the programmes whose teaching language is Turkish should get enough points from Turkish tests of Turkish Teaching Center in order to begin learning after registering. Turkish exam won't be conducted by Selcuk University Coordinatorship for Foreign Student Selection Exam. The Turkish level of candidates who completed secondary education in Turkish high schools linked to Ministry of Education is accepted to be enough. The Turkish proficiency levels arranged by the European Language Porttolio



are listed below:

C2 Level: Turkish is enough. He/She can start teaching. C1 Level: Turkish is enough.He/She can start teaching.

B2 Level: Turkish can improve in a short time. He/She can start learning, but his/her Turkish proficiency levels must rise to C1 or C2 level until graduation.

B1 Level: His/her Turkish level is enough to start learning at our university but he must raise to his/her Turkish proficiency level to C1 or C2 level until graduation.

A2 Level: His/HerTurkish is not enough. He/She is obliged to learn turkish at the end of the year.He/She can start his/ her education after raising the Turkish level to minimum B1 level ,but he must raise to his/her Turkish proficiency level to C1 or C2 level until graduation.

A2 Level: His/HerTurkish is not 14 University Coordinatorship for Foreign Student Selection Exam. The Turkish level of candidates who completed secondary education in Turkish high schools linked to Ministry of Education is accepted to be enough.

## **7)THE REQUIRED CONDITIONS FOR ADMISSION(PLACEMENT) TO THE UNIVERSITY**

The documents required for registration
